MOLD ASSESSMENT COUNTY LIBRARY | HILLSBOROUGH

This library was situated in an Oak Hammock which limited the amount of available sunlight and encouraged humid conditions. Inspection of the ceiling tile and steel supported crossbeams revealed the abundant growth of mildew parallel to the fluorescent lighting fixtures. Inspection of the building revealed that it was under a negative pressure which allowed the interception of outside humid air to be drawn through the building vents, across the plenum and through the ceiling lights. It was suggested that the building's HVAC system be balanced to achieve a positive pressure. In addition, corrections were made to the air conditioning system to allow the HVAC system to run until the indoor air within the building met a particular humidity requirement.

INDOOR AIR QUALITY | BRITISH-BASED OIL COMPANY PROJECT MANAGER | NASSAU, BAHAMAS | 1997-1998

Negative pressure within these administrative offices and the proximity of the offices to emissions from a high sulfur fuel boiler resulted in the interception of off gas products and indoor air quality complaints. Dr. Moon performed occupation health sampling and determined that the indoor air quality closely

paralleled the outdoor air measurements exceeded the U.S. Occupational Safety and Health Criteria.

Severe groundwater contamination resulted in the production and release of hydrogen sulfide vapors that penetrated manufacturing and office facilities at this pharmaceutical plant. The project was initiated following the dissolution of phone lines to the facility and the inability for site workers to occupy portions of several buildings. Dr. Moon's evaluation of subsurface gases revealed that the subsurface conditions were anaerobic and would require both soil vapor extraction and restoration of groundwater. The 10 acre parcel was returned to normal conditions within two years; groundwater conditions were returned to USEPA drinking water standards in six years.

RISK ASSESSMENT | COMPUTER MICROPROCESSOR MANUFACTURER

CO-PROJECT MANAGER | DUPONT, WA | 1997

The proposed construction of a micro processing facility at this former munitions plant prompted an evaluation of inorganic gases and the composition of fugitive dust. The air sampling data was used to perform a risk assessment of air quality residing in the buildings after construction. The outcome of the sampling revealed that conditions were within acceptable occupational safety and health criteria.
